The attendance fees for the AC Academy training programmes were kept the same for the two years. The pre-conference workshop attendance fees for two workshops were reduced in 2020 to attract more delegates. The guest fees for the workshops were substantially reduced to attract "new" people to the ACSG conference activities. Although the member attendance fees for one conference day were slightly decreased, the attendance fees for both conference days were slightly increased. The attendance fees for guests attending one day or both conference days were decreased in the attempt to attract more "new" people.

The sponsorship amount increased with R 67 766 from 2019 to 2020. The meeting concluded that the loss would have been higher if the ACSG had not sourced the sponsorships. It was decided that the committee would continue with the active sourcing of sponsorships.

f. Comparison of venue costs:

The 2020 conference venue costs were R 72 221 less than the venue fees for 2019, meaning that a cost saving was realised.

3. Reasons for the Operating Deficit

The financial loss can be described to:

- Less income R 305 942 was generated during the 2019 2020 financial year compared to the 2018 2019 financial year. Reasons for the less income:
 - The conference income for 2019 was R576 000 compared to the conference income of 2020 of R528 000 (based on the conference spreadsheets). It shows a difference of R 48 000 more conference income during 2019.
 - A decision was taken to keep the conference registration fees the same as 2019 or lower the fees where possible due to delegates complaining that the conference fees were too high during 2019. In addition, a decision was also taken that the ACSG would have a diversified conference rate at the 2020 conference to accommodate students.
 - During the 2018 2019 financial year the AC Academy training generated a substantial amount of additional income apart from the conference income. Training modules were presented to two clients generating the difference in income between 2018 – 2019 and 2019 – 2020 financial year. No additional AC Academy training programmes were conducted in the 2019 – 2020 financial year.

To address the deficit, the following were decided:

- More income must be generated:
 - The AC Academy training modules should be presented in an online format to possibly attract more people internationally to enrol for the programmes
 - Webinars presented throughout the year could be another source of income (although the webinars are mostly a brand building exercise)
 - Sponsorships for year-round expenses could be sourced, e.g., the various costs associated with maintaining an online presence can be funded by a sponsor.
 - The 2021 conference expenses and other operating expenses should be kept at a minimum, while actively sourcing more paying conference attendees for the actual conference (Thursday and Friday).
 - When comparing the annual operating expenses of 2019 and 2020, it seems as though our annual operating expenses are approximately R240 000. It is therefore decided to consider the *annual operating expenses* (R 240 000) together with the conference cost, as well as the market tolerance for conference fees when calculating future delegate conference registration fees and the target number of conference attendees.

4. Acceptance / Rejection of Financial Statements

The meeting agreed to accept the annual financial statements dated 31 May 2020 as a true reflection of the ACSG finances during the 2019 – 2020 financial year.
